NEW TRAILER LIMITED WARRANTY

BARRETT TRAILERS, LLC, PURCELL, OKLAHOMA ("BTL") as herin provided; warrants to the original purchaser that the new trailer manufactured by BTL will be free from defects in materials and workmanship in normal use and service for a 2-year period from the date of delivery to the original purchaser. BTL also warrants to the original purchaser for a 10-year period a limited structural warranty. When properly maintained and used in normal consumer use, the limited structural warranty will include the main frame of the trailer, consisting of the crossmembers, side posts, roof beams, and coupler.

This warranty does not cover tires, wheels, braking systems, landing gear, suspension components, springs, axles and axle components, brake linings, accessories, parts, wheel alignment, or other equipment not manufactured by BTL. If these items are warranted by the manufacturer or supplier thereof, and such warranty may be extended to the original purchaser, BTL will assign such warranties as may be capable of assignment and make available copies thereof for review.

In the event of a defect in material or workmanship covered by this warranty, BTL, in its sole discretion, will:

- a) Collect the defective work or replace the defective parts on a no-charge basis at the BTL plant in Purcell, Oklahoma; or
- b) Reimburse the original purchaser by paying a sum not exceeding the price charged by BTL for such work or parts; or
- c) Provide for repair of the defect or replacement of the defective parts by an authorized BTL service dealer or service center.

BTL may, at its option, require the defective part or trailer to be returned to BTL's main plant, or a BTL authorized service dealer or service center, as BTL may determine. All transportation charges in connection with a warranty claim may be the sole responsibility of the original purchaser.

MISUSE, NEGLIGENCE, OVERLOADING, UNAUTHORIZED REPAIR, ALTERATIONS, OR FAILURE TO PROVIDE NORMAL MAINTENANCE SHALL VOID THIS WARRANTY.

Weights, dimensions, capacities and other measures stated in connection with the new trailer are only estimates and are not covered by this warranty.

THE WARRANTIES SET FORTH HEREIN ARE THE ONLY WARRANTIES APPLICABLE TO THE NEW TRAILER AND ARE EXPRESSLY IN LIEU OF ALL OTHER WARRANTIES, EITHER EXPRESSED OR IMPLIED, INCLUDING BUT NOT LIMITED TO IMPLIED WARRANTIES OR MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

To qualify for protection under BTL Manufacturer's New Trailer Warranty, the registration information form (on the reverse) must be completed, signed and mailed to Barrett Trailers, LLC, within thirty (30) days from the sale of the trailer to the original purchaser.

Any claims under this warranty must be made by the warranty owner, the original purchaser, to the BTL Dealer from whom the trailer was purchased and whose address appears on the reverse of this warranty or to the Warranty Manager at BTL, within two (2) years / ten (10) years structural from the date of the delivery of the new trailer to the original purchaser. Claims received by BTL after two (2) years / ten (10) years structural from the date of delivery will not be covered by this warranty. The Warranty Manager at BTL must approve the warranty claim before any repairs are undertaken. Any work performed without prior authorization will not be covered by this warranty.

BARRETT TRAILERS, LLC SHALL NOT BE LIABLE TO THE ORIGINAL PURCHASER OR ANY OTHER PERSON FOR DAMAGES, INCIDENTAL, CONSEQUENTIAL, OR OTHERWISE FOR BREACH OF WARRANTY, FAILURE OR DELAY IN MAKING DELIVERY, OR FOR ANY OTHER CAUSE, EXCEPT AS SPECIFICALLY SET FORTH IN THIS WARRANTY. BTL SHALL NOT BE LIABLE FOR ANY DAMAGES AS A RESULT OF CARGO LOSS, DOWN TIME, DRIVE TIME, ROAD SERVICE, OR ANY OTHER TYPE OF LOSS DUE TO PERFORMANCE OF THE NEW TRAILER.
